- H.S.L.C/H.S Admit Card/Mark sheet/Pass Certificate as proof of age.
 - H.S.L.C Mark sheet and Pass Certificate.
 - H.S.S.L.C Mark sheet and Pass Certificate (if applicable).
 - Diploma Marksheets (All Semester) and Pass Certificate.
 - CGPA Conversion Formula of the respective institute.
 - Permanent Residential Certificate/Employment Exchange Registration Certificate.
 - State Government Employees of Assam must submit No Objection Certificate from their respective employer or Permanent Residential Certificate/Employment Exchange Registration Certificate as domicile proof.**
 - Caste Certificate in latest format of Govt. of Assam.(if applicable).
 - Updated PwBD certificate. (if applicable)
 - BPL candidates must submit **BPL card reflecting name of the candidate.**(if applicable).
 - Declaration Form A. ("May be downloaded from APSC's website")
 - e-Admission certificate of the Screening Test.**
 - Candidates with documents having inconsistencies in name, father's name etc., must be supported by an affidavit addressing and affirming the correct details. (if applicable)**
 - Any other documents that may be relevant as per Advt.**
- ❖ Candidates must bring one of the following photo identity proofs to be produced on the day of document verification. Photo identity proof includes **PAN Card, Driving License, Passport, Voter ID, Aadhaar Card, IDs issued by Government Departments/PSUs.**
 - ❖ Candidates must ensure their attendance for document verification as per aforementioned date and time. No intimation letter will be issued. Failure to attend for document verification on the date and time mention above will lead to cancellation of their candidature.
 - ❖ It may be noted that being called for document verification does not give the candidate the right to claim for selection to the said post.
